The meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Wednesday, December 17, 2025 at 7 PM at the Village Hall located at 500 North Country Rd., St. James, NY 11780. **RESOLVED**, in accordance with §5-508, the Board of Trustees hereby authorizes and directs the village clerk to post and publish notice of a public hearing on the village's 2026/2027 tentative budget to be held on Wednesday, January 7, 2026, at 7:00 PM to be held at Village Hall, 500 North Country Rd., St. James, NY 11780.
