A meeting of the Architectural Review Board of the Incorporated Village of Head -of-the- Harbor was held on Tuesday, May 6 6, 2025 at 7:00 pm. Project: alterations, windows, siding, roofline change

A preliminary review of the building application and plans was conducted. The scope of work to include a new roof, all new windows, new shake siding, and the addition of stone to the front wall to match the chimney. All exterior lighting must be dark skies compliant. It was, upon motion by Zachary White, seconded by George Layburn, and unanimously adopted.
