Harbor Road debate heats back up

Head of Harbor deputy mayor takes case to Suffolk County legislative committee

Four concerned Head of the Harbor residents, including the village's deputy mayor Lisa Davidson, visited the Suffolk County legislature in Hauppauge Tuesday, June 17 seeking remedy for the Harbor Road dam that collapsed 10 months ago, as the concrete road and dam beneath it continue to crumble further into the mud-flat area that was once Mill Pond.

But whereas their initial lobbying centered on public safety issues such as delayed emergency response resulting from the road's collapse, the deputy mayor quickly turned her focus on Ward Melville Heritage Organization (WMHO) president Gloria Rocchio, who she blamed for stalling progress of a plan remediation between WMHO and Town of Brookhaven (the non-profit

WMHO owns the Mill Pond property, including the land beneath Harbor Road).

"I thought I would help clarify one issue that we keep hearing over and over again: Brookhaven owns the top layer of the road; Gloria owns the bottom portion of the road. And Gloria insists that she will never sign any documentation that implicates her as the owner, because she is concerned about litigation and lawsuits and liability," Ms. Davidson addressed the legislature. "So that's why we are here, because we are absolutely desperate."

During a telephone interview with **The Smithtown News** later in the day, Ms. Rocchio said a reconstruction plan for the road and dam is already being discussed with the towns of Brookhaven and Smithtown as well as the villages of Stony Brook and Head of the Harbor.

"First of all, the title search showing that Harbor Road is a public road [and therefore the responsibility of the Town of Brookhaven] is already up on our website today, and secondly, we did send a proposal to the municipalities as far as how to resolve this measure, and we would like to work with them," said Ms. Rocchio, who noted that Federal Emergency Management Agency (FEMA) reimbursement is rarely available to non-profits and therefore would have to be applied for and obtained at the municipal level.

"I'm acting in the best interest of the WMHO. We reached out to the municipalities on this matter and we are waiting for everyone's response," Ms. Rocchio said. "We hope to get the responses from everyone and be able to meet and put a final agreement together.

"The trustees and the staff of WMHO could not be working harder than we are to get this matter resolved. It's very complicated."

Ms. Davidson dug in even deeper against both Ms. Rocchio and the Town of Brookhaven after the meeting, even though it was the WMHO that already funded and completed the reconstruction of Mill Creek Road in Head of the Harbor, which runs perpendicular to Harbor Road and also collapsed during the rainstorm of August 18/19.

"If that's true—if the surface [of Harbor Road] is owned by Brookhaven and the land underneath is owned by Gloria—and Gloria refuses to sign and Brookhaven refuses to sign again, what do we do?" Ms. Davidson told **The NEWS**. "It's incredible that one woman has the ability to completely paralyze an entire community."

"It's incredibly frustrating to hear over and over

again from all of these different government entities that 1) it's not their problem, and 2) that Gloria needs to step up," she said. "To have Gloria keep reiterating that, no, she's not going to sign leaves us nowhere.

"Both entities are creating an epic problem for the community. It's both Gloria and the town of Brookhaven who are just refusing to work together."

Any combined effort to fix the dam and the road above it, however, will have to be the work of more than just WMHO and the Town of Brookhaven, Ms. Rocchio revealed Tuesday. The village of Head of the Harbor and Town of Smithtown may bear some fiscal responsibility for the public road as well if their geographic portion of Harbor Road—which begins less than 40 feet west of the dam break—must be excavated. Ms. Rocchio said this is a likelihood because there is a concrete structure under the road that carries water from the pond to the historic grist mill just north of the road collapse (the grist mill has been inoperable since the August 19 dam break emptied all of Mill Pond into Stony Brook Harbor).

"The grist mill could be in jeopardy if the road is excavated because the wall in the basement [of the grist mill] is part of the [Head of the Harbor section of the] road," Ms. Rocchio said. "We're working as quickly as possible, and we invite the people from the Department of Homeland Security to come down and see the building and the whole matter as well as anyone from FEMA to see if we can sit down and resolve these matters."

The first person to speak in front of the legislature was Mill Creek Road resident Dan Dresch, who called upon Suffolk County Executive Edward Romaine to take charge.

"For 10 months, we have been in a perfect storm of too many involved parties, political boundaries, vague or contradictory, historical documents and a fear of future litigation. For 10 months, we've been stuck between a nonprofit organization [WMHO], the largest town in Suffolk County [Brookhaven], and their respective lawyers who have dug in for a long, drawn-out battle," Mr. Dresch said. "It's been 10 months. It's time for the county step up and take the lead [to] change the tone of the negotiations.

"Without the Harbor Road connection, public safety is in danger. There are limitations to response time and equipment, therefore requesting that this committee draft the resolution for professionals to study the direct and mutual aid emergency response issues with Stony Brook and St. James

fire departments and recommend short-, mid- and long-term solutions and most importantly, responsibilities. It's time for a high-profile, direct engagement by the county the legislature and the county executive."

Next to speak was Emmett Way resident Beth Zweig. "Because this is a meeting about fire rescue and emergency services, I won't dwell on the dangerous driving conditions on the narrow, curving side roads we must now take on a daily basis. And I won't speculate on what might happen if we have another major storm and the road and land disintegrates further," she said. "But what I do want to say clearly for the record is that the destruction of Harbor Road and the failure of the county to take any action to rebuild this road has resulted and will continue to result in delayed response times for emergency vehicles

in our neighborhood. The county is now on notice. A five-minute delay here and a seven-minute delay there could be the difference between a house saved or a house destroyed by fire, or a person resuscitated by EMS workers or found dead on arrival. It is only a matter of time before the failure to fix Harbor Road leads to some type of catastrophic injury that no amount of money and no number of thoughts and prayers will ever repay," Ms. Zweig said.

Head of the Harbor police chief Chuck Lohmann, who was not at the meeting, spoke with **The NEWS** Tuesday as well. Chief Lohmann, who said he will soon vacate his current trustee designation with WMHO due to any perceived conflicts of interest, noted the changes to traffic patterns and risks that automobile traffic poses to resident pedestrians of Saddle Road and Rhododendron Drive, which cars now must traverse in order to reach the Harbor Road thoroughfare connecting Stony Brook to the rest of Head of the Harbor.

"[The road collapse] has dramatically altered the traffic patterns for residents of the east end of Head of the Harbor on roads not intended for heavy traffic, in particular along Saddle and Rhododendron," he said. "A lot of people walk in that area. Parts of Rhododendron are no wider than 15 feet, and then it's right into the woods. There's no shoulder."

Chief Lohmann said the Head of the Harbor police department has fielded between eight and 12 complaints from pedestrians walking in that area, but that there have been no accidents involving pedestrians.

"There's nothing we can do to limit the volume of traffic," he said, "so we've just increased enforcement to make our presence felt."

The biggest concern he said, though, is the increased emergency response time.

"Time is of the essence, and the most expeditious way [to get to eastern Head of the Harbor] would be Route 25A to Harbor Road," Chief Lohmann said. "This has an impact on response time, there's no question about that. And, as you know, minutes and sometimes seconds can make a difference."

"Thank God we haven't had any serious issues to date, so we've been very fortunate," he said. "Anything that can be done to move this problem forward and come up with a resolution would be very constructive, and the sooner the better."

Ms. Rocchio said the fact that WMHO's proposed plan to work with the municipalities in fixing the (Continued on page 27)

road and the dam beneath it has been leaked to Ms. Davidson and the public interest group "Save Harbor Road" will only delay negotiations for a fix.

"This proposal—a written proposal we never did before, and a document that can be used to settle everythingwas sent to the county, towns and villages and was always meant to be a document that would help us come together and resolve matters," she said, noting that she is unaware how it was leaked. "What concerns us is that a confidential report we sent to elected officials and their attorneys has somehow gotten into this [Save Harbor Road] committee's hands, which really delays coming to an agreement. And on top of it all, pieces of it are being publicized that are incorrect.

"For instance, they are saying we're not going to give the entity [contractors] doing the work access to WHMO land. We did not say that," Ms. Rocchio said. "We said there would need to be a plan to gain access to both areas [the road and Mill Pond]... all we wanted is an access plan."

Ms. Davidson made some serious allegations against Ms. Rocchio, claiming she refuses to apply for FEMA assistance because it would put

WMHO under greater scrutiny.

"I don't think Gloria is taking too much heat. I think... there are probably reasons that she doesn't want to be exposed. She doesn't want people looking into her 501(c)(3). She doesn't want people doing an audit and seeing the books of the Ward Melville Heritage Organization. And that's my suspicion as to why she doesn't [sign an agreement assuming any liability for Harbor Road]," Ms. Davidson said. "[The Town of] Brookhaven, I understand, could do more. I feel they could do more. But I really put this on Gloria. I really do."

"[WMHO] has got millions and millions and millions of dollars in liquid cash assets, and she didn't need to go to FEMA for that money, and [not doing so] protected her organization," Ms. Davidson added. "It didn't open them up to any kind of scrutiny, whereas signing a FEMA contract would. She keeps saying, 'Oh, let's just raise the money privately and have private citizens fix the road.' Why is she saying this when FEMA will pay for it?"

But, as Ms. Rocchio explained, FEMA does not often offer funding to non-profits, anyway, and Harbor Road is technically a public road.
